UNIVERSITY GRANTS COMMISSION QUALITY MANDATE

All HEIs shall strive to achieve the following Objectives by 2022:

- 1. Improve the graduate outcomes for the students, so that at least 50% of them secure access to employment/self-employment or engage themselves in pursuit of higher education.
- 2. Promote link of the students with the society/industry such that at least 2/3rd of the students engage in socially productive activities during their period of study in the institutions.
- 3. Train the students in essential professional and soft skills such as team work, communication skills, leadership skills, time management skills etc; inculcate human values and professional ethics, and the spirit of innovation/entrepreneurship and critical thinking among the students and promote avenues for display of these talents.
- 4. Ensure that teacher vacancies at any point of time does not exceed 10% of the sanctioned strength; and 100% of the teachers are oriented about the latest and emerging trends in their respective domains of knowledge, and the pedagogies that translate their knowledge to the students.
- 5. Every institution shall get NAAC accreditation with a minimum score of 2.5 by 2022.

The following initiatives shall be undertaken in pursuit of the above objectives:

- 1. Induction programme for students.
- 2. Learning outcome-based curriculum framework revision of curriculum in regular intervals.
- 3. Use ICT based learning tools for effective teaching-learning process.
- 4. Soft skills for students.
- 5. Social and Industry connect for every institution: Every institution shall adopt at least 5 villages for exchange of knowledge and for the overall social/economic betterment of the village communities.
- 6. Examination Reforms test the concept, and application; exit examinations.
- 7. Tracking of the student progress after completion of course.
- 8. Induction training for all new teachers, and annual refresher training for all teachers role of the NRCs; and mandatory leadership/management training for all educational administrators.
- 9. Promoting quality research by faculty and creation of new knowledge.
- 10. Mentoring of non-accredited institutions, so that every institution can get accreditation by 2022.

Key Note Address

Introduction:

Improving quality and relevant education continues to be the principal challenge for India. Significant progress has been made in maximising the access to education at all levels. Education plays a vital role in the development of any nation. But, only with increased access to higher education, one cannot account its benefits. Quality education in blend of relevance and excellence in the academic programs offered is equally important. Hence, equity in higher education and excellence in higher education are two sides of the coin that we can call it as development.

Quality Education:

It is time for our country to focus on quality education presently. With raising number of youth population of India, the demographics define that India is going to the country with highest youth population in the coming decade. Hence, needless to say, the youth of India will be the largest stake holders in defining the needs of change in different aspects of governance. Youth will be everywhere, and this gives immense power to make change and create the difference.

As like any other field, education also will go through a massive and immense change that suits the requirement of the pupil. This is going to be the maiden attempt to understand and prepare the youth of the nation for the future that this is what we call as "future ready education". This education will comprise of all components that an individual will require for employment, making of good citizen and overall well-being. Now, let us define "Education 4.0". In line with "industry-4.0" we should have "Education 4.0". The first industrial revolution spoke about improvising the industries in 18th Century. In the 19th Century, the second industrialization spoke about technological revolution. The third industrial revolution in the 20th Century spoke about the digital revolution. The fourth industrial revolution is now with the Internet of Things, Big data Analytics, and cloud computing and so on. Hence Education 4.0 is required to be in- line with the industrial needs to embrace new culture of disruptive education. The future of education is going to be at best with the alignment of Man and machine to innovate new learning possibilities. This could be a focus of Out-come Based Accreditation that the New Education Policy has recommended.

The outcome of education should not be merely economically valued. But relevance of the same in the social, cultural, environmental and other wellbeing concepts need to be delivered in an amalgamated benefit.

Path-Finding Quality Education

Where and how to state the infusion of quality in the present system needs to be answered. If we see the knowledge cycle, the first parameter or component is generation of knowledge. The materials and pedagogies of teaching-and learning need change. The curriculum frame work needs more inclusive of skills that is required for employment. Hence, present syllabus should incorporate components of requirements that are determined by the employing industry. It can be simplified in the terms that our present teaching-learning pedagogy requires paradigm shift.

Once the curricular framework is made ready, then focus is to the dissemination of knowledge. While a good and tasty food visualised and recipe is made ready. One has to prepare it and serve and eat it. The recipe can be compared with the syllabus. But the actual preparation is the faculty who delivers the content to the students. The faculty should be enabled to deliver the contents effectively to the students. Necessary ingredients, that is, infrastructural arrangements should be enabled for effective knowledge transfer.

Assuming that the syllabus is ready, the faculty are enabled with efficiency to deliver. Now, it comes to application of knowledge. The stages of learning should not just stop with understanding and reproducing the same in the examination. Te system should provide ample space and opportunity for students to ideate (conceive ideas), experiments and apply their class room knowledge in the real world context.

Finally, teaching-learning experience should be governed by the principles of student-centric and relevance driven.

Factors that require augmentation

Capacity building of the teachers is the foremost important step here. While framing a relevant curriculum is an achievable goal. But, building the capacity of those ambassadors, who are going to give life to the mere words in the syllabus, plays a critical role here. They should just not cover syllabus, but uncover the quest to learn for the students. They should uncover every positional opportunity for higher learning and employment that lies hidden behind the syllabus.

Adequate training needs to be provided for delivering a personalised and engaging education. Often, the connect between the student and teacher, just limits with the syllabus. But, now it is importation to extend this connection to the real world experience and experiment. Use of digital mediums are all the more required. Of all the requirements specified in every job requirement, digital literacy is the most emphasised.

How to make it happen

The thought of quality education is well conceived, but how to revoke the same in reality is a big picture that needs more investment of Higher Education Institutions in technology, acknowledging the use and benefits. The paradox of whether teacher delivered lectures or teacher -less lectures need to be cautiously decided. Leverage on appropriate balance between online-and conventional learning needs to be adopted. The employability skills need to be amended into the syllabus so that the students are equipped to face the

digitally driven world. The visionary leaderships are all the more important to turn all impossible to possible outcomes.

Challenge to be faced

Quality education is unlikely to be achieved through focusing on any single strand or dimension of education practices. Transformational change towards enhanced quality education will therefore depend on a holistic, coherent and interrelated approach. Organizations like NAAC, has already involved process and measures incorporating the changes. Change is apparent and unavoidable. If institutions do not adapt the change, they will have to face the effects in multi factors and multi layers. The institutions will find it challenging to see their students employed. The institutions that resist change will face the issues in accreditation performance.

What sails with us?

In Indian history, we have a rich heritage and knowledge that we need to be proud of. The knowledge of the past coupled with the wisdom of the present will have to define the directions for the educations. Simple adoption of any western curriculum will not suffice. From a traditional society, today we are experiencing rapid transformation leading to modernization. The impact is felt socially, culturally, economically, politically and technologically. These changes will continue to throw challenges mismatching between differential demand and ill equipped supply of human capital. The change is being faster than the adaptation resulting in net difference in supply. The escalating pressure of growing expectations of the rest of the world on us coupled with aspirations of our young minds and the inevitable demography, urbanization, mobility across border will make the situation more explosive. Then, we will have no other to change but will be forced to change. Hence better embrace change before it forces to change.

What will sail with us is only our continued perseverance toward quality education and hope to create better world to live.

Secret of Success

A major success factor any outward looking Higher Educational Institutions is their capacity to perceive in advance, the opportunities, challenges and threats which are likely to affect its performance. So, institutionalising quality should be an internal affair of institutions. Then it shall not be defined or enforced by any external organisations. Institutions should just not "see change" but also "foresee change" and develop adaptability.

To conclude

Education is the passport to the future, for tomorrow belongs to those who prepare for it today.

This approach will include various outreach programmes and activities such as Workshops, Conferences, symposia etc. Such outreach programmes will give favourable results if a two-way or multi-way process is employed where both the UGC and the Higher Education Institutions reciprocate and bring in quality as an inherent virtue.

The UGC has always laid an emphasis on research and capacity building among the Higher Education Institutions in India. The accreditation of all the Higher Education Institutions should be done on revised parameters which support the 'Quality Mandate' of the UGC. To ensure smooth functioning of the 'Quality Mandate', the UGC has come up with many programmes with proactive measures. STRIDE is one such visionary step taken in that direction of quality and capacity building among academicians and learners. STRIDE focuses on the various dimensions of research and capacity building which includes providing funds, especially to streams such as Humanities and Education Studies which are not provided with as much funding by the UGC as the other streams. The STRIDE has three components or elements: a set of clear objectives which the researchers can choose as per their convenience, an aim to support and improve lives of people and a microscopic focus on the Humanities Stream under National Network Project.

Dikshaarambh is yet another programme the UGC has launched. It is a student-centric induction programmeto acquaint students with the system. The UGC has conducted several sessions with various State and Central Universities across the country to train and guide the academicians and representatives of the Higher Education Institutions so that this pragramme can be carried out in a smooth and hassle free manner.

The spirit of innovation and academic efforts should be strengthened and in order to do that certain revisions in the quality mandate and management parameters are possible. To ensure a continuous journey towards quality we should diligently follow the Hub and Spoke model where the UGC is directly linked at the centre with all the Higher Education Institutions around it. The UGC is planning to designate 'Academic Accreditation Ambassadors' to help carry out the 'Quality Mandate' successfully and effectively. Inclusive approach such as Synchronization of the governing bodies such as the UGC and the NAAC could also pave way in the direction of academic excellence in all respects.



UGC QUALITY MANDATE

It is a wonderful opportunity for all associated with teaching, learning and education system to have gathered here in a common platform to understand and address the new policies which focuses to reshape higher education in India. To transform the higher education in India working at the grassroot level for the implementation of policies holds a chief importance. Since India's demographic diversity is very vast, it demands holistic development of our students having different talents and scope. Therefore nurturing them in the best possible way is necessary for the growth of a peaceful and prosperous society as well as nation.

Historically speaking Indian higher education is the largest education system having central, state, private and deemed universities. There are wide variety of educational degrees from different faculties, disciplines and departments offering courses, programmes and skill development modules.

Speaking of quality is a necessary arena to be discussed and explored in higher education. Quality enhancement is a continuous process. It should not only have a single system of assessment but should follow various methods and parameters of evaluation. It keeps on improving when higher education is concerned. This leads us towards brand building exercise where quality alone survives. To throw more light on this aspect I would like to describe the Eco System of Quality. This Eco System includes different bodies of an educational institution. They are as follows:

- a) **Academic Model** This area talks about the type of education provided by a particular academic institution with certain objectives and purposes.
- b) **Faculty** An important entity which facilitates encourages and motivates students to love and appreciate learning. They are the core centre of any institution. They are also the leaders to promote the new culture of teaching profession.
- c) **Infrastructure** For quality enhancement every college and university should take cognizance of this part as modern education is based on it.
- d) **Pedagogy** Advanced system of assessment, curriculum development, unifying old and new teaching learning processes and methodologies are the essential areas for strengthening education.
- e) **Research** Much analyzed, discussed and broad area vital for the expansion of education and development of the nation.
- f) **Collaboration** For promotion of modern systems of education and liberating faculties and disciplines from age old streamlined courses interdisciplinary and multidisciplinary academic courses should be introduced and encouraged.
- g) **Accountability and transparency** Every information and regular functioning of the institution should be available online for the students. In this way students, teachers, non teaching staff can work

effectively and will remain responsible towards higher education.

The origin and meaning of quality hence is ever changing and ever growing in the field of higher educational development. To set a target in achieving quality education and future for students UGC has upheld some objectives of quality mandate. This mandate firstly aims to improve the quality of graduates with better employability skills. Secondly it focuses on the development of soft skills among students. Thirdly the accreditation of institution should be taken seriously by the apex bodies to promote quality enhancement. Fourthly vacant teaching positions should be filled up for stability of favorable academic environment. Lastly linkages with industry and employment sectors should be created in order to facilitate more and more placements.

It is quite certain and clear that a good education system is therefore interlinked with quality and progress. UGC in order to initiate this process of quality enhancement started with many schemes and policies. One such initiative is Deeksharambh. This is purposely designed for students taking admission in colleges, universities and institutes for the first time. This student induction programme for six days aims to familiarize and bond the students with the new institution. Different activities like mentoring, familiarizing with departments, creative arts, literary activities, lectures of eminent personalities and visits to local areas are organized to impart human values among the students.

Apart from this UGC also defines Learning Outcomes Curriculum Framework for higher educational institutions. This has introduced the interdisciplinary and multidisciplinary approach towards educational programmes and degrees. More focus is given to practical and pragmatic methods of learning. Inclusion of more field work, technological intervention and imbibing soft skills is the nature of this particular scheme. The higher education now looks forward to establish twentieth century skills among the youth of this country. Critical thinking, analytical thinking, multicultural awareness, reflective thinking and self directed learning are the demands of the current professional world. Hence ICT based learning is essential for students to avail the latest and vibrant courses offered by UGC. Programmes like SWAYAM and MOOC has 58 courses and till now there are 40711 learners registered for different topics and disciplines.

As quality and learning outcomes are necessary to consider, promotion of life skill studies is also introduced through university and industry linkages. They endorse for better employability skills which includes communication skills, professional skills, leadership and management skills, entrepreneurship skills and universal and human values. This directs us obviously towards a transformed evaluation process. Higher educational institutions now should ponder upon the renewed objectives of examination system. A separate suitable model for UG, PG, M.Phil and PhD should be developed. Hence internal and continuous evaluation of the current systems should be done.

Considering all the changes and initiatives taken by UGC, NAAC and other higher authorities, it is significant and crucial to now open our eyes towards a rapidly emerging glocal culture. This multicultural base now reconciles the local and global. Together they are meeting the challenges of education, economy and development. For this reason revamping, re- evaluation and re-examining of education policies should be done for advance learning opportunities. The twenty first century has turned a new page towards ever changing educational system which eyes the different avenue to uplift youth welfare in all possible mediums. Its approach is to reach out to the entire length and breadth of India. UGC, to ensure quality in Higher education, has come up with various outreach programmes and activities which emphasize on Research and capacity building among the Higher Education Institutions in India. Such an approach will give favourable results if we employ a two-way or multi-way process where both the UGC and the Higher Education Institutions reciprocate and bring in quality as an inherent virtue.

The Consortium for Academic and Research Ethics (CARE) is a landmark initiative taken by the UGC to curb the sudden upsurge of predatory journals in the UGC list. The UGC's endeavor through CARE is to compile a list of credible and good journals, termed as CARE list of Journals. This step will curtain and stop the illegal journals responsible for the bad condition of research in our country. The UGC has also established CARE centers across India in all geographical regions such as Baroda, Hyderabad, and New Delhi. The designated institutions across the nation will be charged with the task of verifying these journals for false information. The prime objective of CARE is to enhance and maintain the 'Quality and Ethics' in research activity. Let's regain the reputation of Indian Academia through the revival of quality and ethics in Indian academic and research activities. Let's have a zero tolerance attitude towards false, deceptive journals.

The Internal Quality Assurance Cell (IQAC): Rationale and Role in Institutional Quality Enhancement.

IQAC: Rationale and Role in Institutional Quality Enhancement

Quality is a conscious and consistent process of improvement. It is a distinctive attribute where there is no 'secondary' approach. Higher education in India is progressing leaps and bounds. Available facilities, space, manpower, resources, up-gradation and thought process all need conscious and consistent approach, and these are the areas where a higher educational institution needs to improve.

The role of IQAC sets its tone here. Organizations and individuals do not try to find out the changes that are taking place around them and at large all over the world. This approach deprives the individual and organization from upgrading. The role of IQAC is to look at the changes around it, go for a conscious thought and then change in the way the organization deserves to be. Quality chase cannot be blind and with duplicity.

For a change to be realized, firstly, we need to understand the "baseline". Unless we have the baseline it is impossible to scale the heights of quality. To know the baseline we need to understand the processes, procedures and policies of IQAC. Every organization has hundreds of processes, however in most organizations these processes are not put on paper.

A policy statement is the end result based on the processes and the procedures for a particular area. Unless we are aware of these areas and the baseline at which they operate, we cannot succeed in implementing the policies. By understanding the processes we can improvise and make them effective. Effectiveness helps us to reduce the unwanted efforts and helps the organization to improve its relationship within the employees.

A regular training and updating in the areas of the work by the experts and knowledgeable sources, imparting the skills to the workforce provide a gradual improvement in the quality of transactions of the deliverables. A trained force has better chances of promoting individual and organizational development. It also helps the organization in keeping the staff engaged in the developmental processes enhancing the quality culture.

Quality comes with a value system. The organizational framework helps delivering skills to help students develop global competency, national development, striving for excellence and the use of technology. These always come with core values of the individual. The development of individual goes in hand with the development of the organization. Successful organizations always create successful individuals.

Lastly, these processes and values end up with the process of implementation. Implementing quality at individual level is character building, at institutional level it would be designing and implementing the processes, procedures and policies. This would in turn mean deployment of educational processes, training and achieving predefined targets. The processes need to be controlled and measured with the help of audits and its data be analyzed for improvements to see whether the organization is in the direction it wishes to go.



Outcome Based Analysis in The HEI Accreditation Process

Outcome Based Analysis in the HEI Accreditation process

The process of Assessment and Accreditation in India was evolved by NAAC in the year 1994. It was established as per the recommendation of then Education policy 1986, with its headquarters in Bengaluru. NAAC basically Assesses and Accreditates the institutions of Higher Education, through its internationally accepted methodology. It has a vision of to make quality the determining element of instrument of higher education, through internal and external quality evaluation, promotion and sustenance initiative.

Assessment and Accreditation is broadly used to understand the quality status of an institution. In the context of Higher Education, accreditation status indicates that a particular Higher Education Institution, whether it is University or recognized units there-in, meets the standard of quality as set by the Accreditation agency in terms of its faculty, research, student's infrastructure, library, learning resource, financial services etc.

NAAC, since its inception has Accredited around 8331 in its first cycle and 12990 in number of Accreditation till date, which is highest in the world in terms of any Accreditation agency.

Basic concept: The basic concept on which NAAC accreditates the HEIs are its seven criteria. At present these criteria are elaborated in the form of key Indicators which are 34 for Universities and Autonomous, while 32 are for Affiliated colleges. These key Indicators are further bifurcated in Metrics, which are in the form of 137 for Universities, 136 for Autonomous and 121 for Affiliated. Quoting an example of Affiliated colleges which has 121 metrics can be varied as 30 input based 53 process based and 38 outcome based metrics. It means there are less number of metrics which are outcome based. The major chunk is taken care by input & process based metrics.

Outcome Based Accreditation (OBA): The present draft NEP & EQUIP document suggests Outcome Based Accreditation, thus there is an outrage demand for the same, probably considering its practical long term benefit.

OBA Definition: An accreditation done by the agency on the basis of output of HEI. Outcome Based Accreditation (OBA) will focus on evaluation of outcomes of the courses/program offered by HEI through input and output criteria/indicators.

OBA will go with concept of KASH i.e. OBA will provide Knowledge, Attitude, Skill and develop good Habit among students, that will change the scenario of the whole education system.

OBA will drive quality of HEI with student's achievement.

INNOVATIVE AND BEST PRACTICES IN HIGHER EDUCATION

Present education scenario: As per data extracted from MHRD website 36.6 million i.e. 36.6 Million students are taking Higher Education with 14.1% in Engg, 17.1% in Science, 14.1% in Commerce & 36.4% in Arts stream. NASSCOM says only 25% of Engg. graduates and 10% of other graduates are employable. Thus unemployment ratio is highest in India i.e. around 6.1%. An eventual solution for this major problem is OBA. Let us understand with example: An institution name XYZ has 1000 graduates coming out every year. In the name of placement cell the institution is able to provide jobs to 20% of its students, rest 80% students career is left to their destiny. This story is with almost every institution in our India, resulting in to the quantum of educated unemployed.

NAAC has a stake in Higher Education System, as it is related with the grade of the HEI and such grade/accreditation is allied with funding from government & other resources. Thus NAAC's A&A process and policy matters a lot. The tool can be framed in such a way that the institution may force to think/take relevant steps for fulfillment of the required data for the said metrics, which eventually derives quality & outcome of the HEI.

OBA Parameters: Outcome Based Accreditation (OBA) can be trifurcated into three:-

- a) Student Based Outcome (SBA)
- b) Institution Based Outcome (IBA)
- c) Teachers Based Outcome (TBA)

This will help the institution to focus on all the outgoing students' career and will do the needful to equip, their skill or provide related education, so that maximum students can proceed further with their career. This will also indirectly help the students to be skillful as only 2.3% of our workforce is skillful as compared to 96% South Korea, 80% Japan, 75% Germany, 68% UK & 54% US. Thus it is worrisome part with our education system and so the economy. This can be sorted out if we go with OBA process of Assessment & Accreditation of the Institution.

In OBA process, number of Metrics can be reduced, making more easy, flexible & achievable. This will bring revolution in the Higher Education System and will support/boost our economy by making its human resources skillful/employable.

Response Ability

Since the existence and establishment of quality improvement process is at work in all educational institutes, it is commendable to witness the awareness and knowledge exploration worked out by various higher educational institutions to claim its position in NAAC. As the apex bodies of education raising its standard of learning and teaching, all academicians and administrative bodies should work to



maintain transparency and accountability in higher educational institutes. Hence my current concern is to elaborate the meaning of responsibility attached to the profession of teaching and learning considering NAAC and current education policies. I have perceived a different view of the word responsibility by joining Response and Ability.

Response is natural and spontaneous. But as it is said with "more power comes more responsibility" and maintaining quality with a sense of responsibility is a necessary criteria. To maintain quality one institution has to go to cycles of accreditation and reaccreditation. But this continuous process offers more chance to come closer to perfection. Quality should be achieved in a step by step method. We cannot jump to quality. Considering the strengthening of quality of educational institution, it will be apt to understand that achieving quality is an eternal process. Noticeably it will follow cycles. These steps and cycles are assessment, error detection, correction and reassessment. Moreover when quality is a paramount importance for NAAC more number of cycles would lead to perfection. The Internal Quality and Assurance Cell should therefore function in a system centric manner rather than in individual centric manner. All organizations necessarily maintain and follow a system of work.

During NAAC visits in colleges and universities, it is seen that the answers to different criteria's and their related questions are wisely fit into the compliances. Gradually the strategies of facing NAAC visits have become stereotypical. The question here arises with the grades that each college or educational institute gets and aims for, from these accreditation process. The grading process expects to tag the institution with the parameters of quality. Colleges getting A++ and A+ are claimed to be best higher educational institutes. But where does it stand after five years? Going again for reaccreditation and assessment doesn't generally promise the consistency of outstanding grades. Just like reference line and control lines go up and down, grading never remains consistent.


As quality is considered to be a continuous process certain parameters are essential to maintain accountability of each and every aspect of the academic institution, a uniform 'system' should be followed. Without a uniform 'system' there is a great scope for deadly fluctuation in the grades of any institution. To function in a uniform system, core quality assessment, compliance quality analysis and digitization are important factors. Higher education institutes have many parameters handled by a feedback system. This mechanism helps to develop and improve quality of the institution. Assessment of curriculum, faculty performance and infrastructure and support system are crucial factors coming under the parameters of feedback system.


Implementation of a principled system of functioning of education policies is required. But implementation of policies and innovative methods does not only mean proof of paper but execution of activities expressed through physical existence of quality and healthy practices. An idea to work before timeline ends should be adopted and followed.

Core Values of NAAC and their reflection in Assessment and Accreditation




